The City of Signal Hill appreciates your attendance. Citizen interest provides the Council and Agency with valuable information regarding issues of the community. Meetings are held on the 1st and 3rd Tuesday of every month. In addition, meetings are streamed live on our website at [www.cityofsignalhill.org](http://www.cityofsignalhill.org), and are televised at 7:00 a.m., 2:00 p.m., and 7:00 p.m. every day on Charter Communications Channel 3, and Verizon FiOS Channel 38.

Meetings commence at 6:00 p.m. with the conduct of any business permitted to be conducted in closed session by the Brown Act (Government Code Section 54950, et seq.), if any, and with the public portion of the meeting commencing at 7:00 pm. There is a period for public comment on closed session matters at 6:00 p.m. prior to the closed session. In the event there is no business to be conducted in closed session, the regular meeting shall commence at 7:00 p.m. There is a public comment period at the beginning of the regular meeting, as well as the opportunity to comment on each agenda item as it arises. Any meeting may be adjourned to a time and place stated in the order of adjournment.

The agenda is posted 72 hours prior to each meeting on the City's website and outside of City Hall and available at each meeting. The agenda and related reports are also available for review online and at the City Clerk's office and Library on the Friday afternoon prior to the Council meeting. During the meeting, the City Manager presents agenda items for Council consideration. The public is allowed to address the council on all agenda items. The mayor will announce when the period for public comment is open on each agenda item. The public may speak to the council on items that are not listed on the agenda. This public comment period will be held at the beginning of the public portion of the meeting. You are encouraged (but not required) to complete a speaker card prior to the item being considered, and give the card to a City staff member. The purpose of the card is to ensure speakers are correctly identified in the minutes. However, completion of a speaker card is voluntary, and is not a requirement to address the council. The cards are provided at the rear of the Council Chamber. Please direct your comments or questions to the Mayor.

(11) PUBLIC HEARING

- a. Public Hearing – Introduction of an Ordinance Amending Signal Hill Municipal Code Chapter 13.03 by Repealing Chapter 13.03 and Replacing it with a Revised Chapter 13.03: Water Conservation Program

Summary: The City of Signal Hill Municipal Code Chapter 13.03 enables the City Council to establish a water conservation program to minimize the effect of a shortage of water supply on the City's residents and businesses. As required by Signal Hill Municipal Code, the City Council must hold a noticed public hearing and make appropriate findings to amend the City's water conservation program.

Recommendation: Waive further reading and introduce the ordinance amending Chapter 13.03 of the City of Signal Hill Municipal Code relating to the water conservation program.

## (12) ORDINANCES

- a. Second Reading and Adoption of an Ordinance to Amending Section 5.18.060 of Chapter 5.18 of the Signal Hill Municipal Code Relating to Inspection of Guest Registration Cards

Summary: Ordinance No. 2015-09-1477 was introduced at the City Council meeting of September 1, 2015, and is now presented for second reading and adoption.

Recommendation: Waive further reading and adopt Ordinance No. 2015-09-1477 Amending Section 5.18.060 of Chapter 5.18 of the Signal Hill Municipal Code Relating to Inspection of Guest Registration Cards.

- b. Introduction of an Ordinance Amending Sections 2.08.040 and 2.36.060 of the Signal Hill Municipal Code to Change the Meeting Days for the Regular City Council Meetings and the Regular Planning Commission Meetings

Summary: The City Council will consider introducing an ordinance to change the City Council meeting dates from the first and third Tuesdays of each month to the second and fourth Tuesdays each month. Additionally, the meeting of the Planning Commission will change from the second Tuesday each month to the third Tuesday each month.

Recommendation: Waive further reading and introduce the ordinance amending Sections 2.08.040 and 2.36.060 of the Signal Hill Municipal Code to change the meeting days for the regular City Council meetings and the regular Planning Commission meetings.

## (13) CITY MANAGER REPORTS

- a. Resolution Approving Memorandum of Understanding with the Signal Hill Police Officers' Association

Summary: Representatives from the Signal Hill Police Officers' Association and the City have completed negotiations on a successor Memorandum of Understanding (MOU). Presented for City Council consideration is the resolution approving the MOU.

Recommendations: 1) Waive further reading and adopt the resolution amending Resolution No. 2013-12-6051, approving a Memorandum of Understanding pursuant to the California Meyers-Milius-Brown Act by and between the City of Signal Hill and the Signal Hill Police Officers' Association; and 2) Approve the attached budget adjustment reallocating \$175,000 for FY 2015-16 from already appropriated funds.

c. Environmental Assessment Services Contract

Summary: The City Council will consider entering into a Contract Services Agreement with Mearns Consulting, LLC (herein "Contractor") to provide specialized environmental assessment services. These assessment services are needed in order to sell property formerly owned by the Signal Hill Redevelopment Agency. The types of services to be completed by the Contractor include: Phase I and Phase II environmental site assessments, soil vapor surveys, Human Health Risk Assessments, soil management plans, methane assessments, well assessments and project management.

Recommendation: Authorize the City Manager to enter into a Contract Services Agreement with Mearns Consulting, LLC for environmental assessment services.

Summary: The City of Signal Hill is a member of the Los Angeles Gateway Region Integrated Water Management Authority and serves on the Governing Board. Staff is recommending appointing the Public Works Director as the Secretary and Treasurer and the Deputy City Manager as the alternate Member.

Recommendations: 1) Appoint the Director of Public Works as the Secretary and Treasurer of the Gateway Region Integrated Regional Water Management Authority Board; 2) Appoint the Deputy City Manager as the alternate Member of the Gateway Region Integrated Regional Water Management Authority Board.

b. Schedule of Investments

Summary: The Schedule of Investments is a listing of all surplus funds invested for both the City and the Successor Agency of the former Signal Hill Redevelopment Agency as of the date shown on the report.

Recommendation: Receive and file.

c. Warrant Register Dated September 15, 2015

Summary: The Warrant Register is a listing of all general checks issued since the prior warrant register and warrants to be released upon City Council approval.

Recommendation: Authorize payment of Warrant Register dated September 15, 2015.
