### **(C) CHANGES TO FEE WAIVER POLICY**

Vice Chair Kiss-Lee asked if we receive requests from Long Beach or other surrounding areas wanting to use our parks. Director Mancini informed the Commission that we do receive requests and anyone can rent, but this addresses the Fee Waive policy.

Vice Chair Kiss-Lee suggested offering a 50% waiver for non-residents/organizations. Director Mancini stated that policy change would have to go before the City Council.

Commissioner Dudley clarified the organization board must be at least 51% residents.

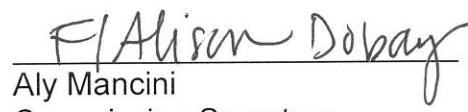
