## **(B)    NEEDS ASSESSMENT**

Director Aly Mancini introduced Richard Fisher & Associates represented by Richard Fisher and Sue Leto.

Richard Fisher and Sue Leto gave a brief overview and summary of the report.

Commissioner Russell expressed an interest in teen and senior volunteerism. Commissioner Russell also suggests an “end of program” matrix of how many families attended a program and their feedback along with data to send out to business sponsors showing the impact and value of their sponsorships. Commissioner Russell also supports the idea of a Resource Guide for the community.

Vice Chair Kiss-Lee commented on support for multigenerational volunteerism and possible partnership with Browning High School/LBUSD.

Commissioner Dudley commented in favor of a transportation loop. Commissioner Dudley thanked consultants for their work.

Commissioner Rogers suggested networking with the JCC. Commissioner Rogers recommended all non-profits working together to draft an events calendar at the start of each year.

Chair Lauer expressed concern about Hispanics/Latinos be properly represented in surveys, only 15% participated in phone survey; however, Hispanics/Latinos are 33% of our community. Richard Fisher clarified the telephonic survey was randomly selected by computer, not by demographic. Chair Lauer would like to see a specific plan to include this sizable portion of community in all future surveys. Chair Lauer asked if there was

any recommendation to provide information on city website, electronic board, and any other media in Spanish? Richard Fisher commented that this is a good recommendation.
