b. Resolution Designating Authorized Agents of the City of Signal Hill for California's Office of Emergency Services Public Assistance Grants

City Manager presented the staff report.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, DESIGNATING THE CITY MANAGER, THE CHIEF OF POLICE, AND THE DEPUTY CITY MANAGER AS AUTHORIZED AGENTS TO EXECUTE APPLICATIONS ON BEHALF OF THE CITY OF SIGNAL HILL FOR THE PURPOSE OF OBTAINING POST-DISASTER ASSISTANCE GRANTS FROM CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES AND FEDERAL EMERGENCY MANAGEMENT AGENCY
