Meetings begin at 6:00 pm with the conduct of any business permitted to be conducted in closed session by the Brown Act (Government Code Section 54950, et seq.), if any, and with the public portion of the meeting beginning at 7:00 pm. There is a period for public comment on closed session matters at 6:00 pm prior to the closed session. In the event there is no business to be conducted in closed session, the regular meeting shall begin at 7:00 pm. There is a public comment period at the beginning of the regular meeting, as well as the opportunity to comment on each agenda item as it arises. Any meeting may be adjourned to a time and place stated in the order of adjournment.

The agenda is posted 72 hours prior to each meeting on the City's website and outside of City Hall. The agenda and related reports are also available for review online at www.cityofsignalhill.org.

Summary: Annual review of the Records Retention Schedule has been completed. The changes to the Records Retention Schedule have been submitted by the City Clerk, approved by the City Attorney and now require City Council approval. This action would amend the Records Retention Schedule for the Administration, City Clerk, Community Development, Community Services, Economic Development, Finance, Personnel and Public Works departments.

Recommendation: Waive further reading and adopt a resolution amending the City's Records Retention Schedule previously adopted by Resolution No. 2020-10-6594, and repealing all prior resolutions.

b. Contract Amendment Register Dated July 13, 2021

Summary: The Contract Amendment Register is a listing of proposed contract amendments eligible for streamlined processing based upon the following criteria as documented in the City's Purchasing Policy:

- Funds have been authorized as part of the adopted fiscal year Operating Budget;
- Staff are satisfied with the goods/services received to date; and
- City Manager has reviewed and approved each amendment for streamlined processing.

All amendments have been prepared in a form approved by the City Attorney.

Recommendation: Authorize the Contract Amendment Register dated July 13, 2021.

Summary: The Warrant Register is a listing of all general checks issued since the prior warrant register and warrants to be released upon City Council approval.

Recommendation: Authorize payment of Warrant Register dated July 13, 2021.
