**CALL TO ORDER**

**INTRODUCTION OF NEW FRIENDS OF SIGNAL HILL LIBRARY PRESIDENT**

Community Services Director Alcivar-McCoy introduced Wayne Moore, the new president of Friends of Signal Hill Library.

**PRESENTATION(S)**

City Manager Ken Farfsing provided an update of the status of the Library project. He explained the impact of ABx1 26 and AB 1484 on redevelopment agencies. The City is currently working to complete the requirements needed to obtain a Finding of Completion and is optimistic that the process will have a successful outcome.

**DISCUSSION ITEM(S)**

- (A) **ATTENDANCE AT 2013 CALIFORNIA PARKS & RECREATION SOCIETY ANNUAL CONFERENCE**

The Commissioners discussed their attendance at the March 2013 California Parks & Recreation Society (CPRS) annual conference. Commissioner Damrow is interested in attending, and Commissioner Davis declined. The Commission directed staff to revisit this item at the January Parks & Recreation Commission meeting to provide time for other Commissioners to check their availability.

**(B) TOUR OF CITY FACILITIES**

Following the meeting in Council Chambers, the Commission continued the meeting with a vehicular and walking tour a of the City facilities, reviewing capital improvements, rehabilitation projects and the maintenance in each. Vice Chair Cunningham requested to be excused from the tour.

The Commission noted that the inside of the Youth Center building and the Discovery Well Park Community Center need to be painted.

**(C) UPDATES ON CITY COUNCIL ACTIONS, PARK PROJECTS & PROGRAMS**

Staff provided an update on various actions which affect the Community Services Department such as City Council direction, project status for park development, or other Community Services programs which have changed over the previous month.

Community Services Manager Mancini highlighted the Volunteer and Sponsor Recognition Banquet, the new WiFi service at the Library, and the assistance of volunteers in the Library.

It was moved by Commissioner Damrow and seconded by Vice Chair Cunningham to receive and file report.


