**(A)    WORKSHOP/CIVIC CENTER MONUMENT SIGN WITH ELECTRONIC MESSAGE CENTER**

Community Services Director Alcivar-McCoy provided information about noticing of the electronic sign to the community, and presented the staff report. Steve Myrter, Public Works Director, reviewed the traffic report and site and safety analysis. Bill Zimmerman of Zimmerman Engineering presented the engineering findings.

Director Alcivar-McCoy provided answers to the questions asked.

It was moved by Commissioner Davis and seconded by Commissioner Lopez to request staff to review the option of solar power, the location of the sign, and the issue of light pollution. A second workshop will be held in April. Noticing will be provided to homes within 1,000 feet, will be put on the website, delivered via utility bills, mailed directly to all homeowners' associations and advertised in the newspaper.

#### **(B) UPDATES ON CITY COUNCIL ACTIONS, PARK PROJECTS & PROGRAMS**

Staff provided an update on various actions which affect the Community Services Department such as City Council direction, project status for park development, or other Community Services programs which have changed over the previous month.

Community Services Manager Mancini highlighted the return of the school children following the winter break. She also indicated the popularity of the Wi-Fi connection at the Library and pointed out a pie chart provided by the Librarian showing the large number of adult patrons (approximately 60% of patrons).

Chair Dudley indicated the park area by the new library will be Wi-Fi accessible.


There were no items agendized for the next meeting.
