c. Consideration to Support AB 741

City Manager presented the staff report.

Council Member Woods requested clarification to the public that this is not an increase in property taxes. City Manager confirmed this is not an increase in property taxes.

It was moved by COUNCIL MEMBER FORESTER and seconded by COUNCIL MEMBER WOODS to waive further reading and adopt Resolution No. 2013-04-6014 to support AB 741(Brown) to add Section 98.3 to the California Revenue and Taxation Code which proposes to ensure that qualifying cities receive a minimum amount of ad valorem property tax revenues necessary to maintain services.

**CONSENT CALENDAR**

a. Purchase of Two Replacement Public Works CNG Trucks

Summary: Staff is seeking authorization to purchase two replacement CNG trucks for the Public Works Department. Staff proposes to purchase these vehicles from Wondries Fleet Group. This purchase will "piggy back" on the State of California, Contract number 1-13-23-20F.

Recommendation: Authorize the Vehicle and Equipment Services Division to purchase two new 2013 Ford F250 pickup trucks from Wondries Fleet Group through the State of California, Contract number 1-13-23-20F.

- b. Extension of Contract Services Agreement with Proscape Landscaping, Incorporated for Landscape and Lighting Maintenance District No. 1 (LLMD No. 1) Landscape Maintenance Services

Summary: In 2008, the City entered into a contract services agreement with Proscape Landscaping, Incorporated (Proscape) to provide landscape maintenance services for the Landscape and Lighting Maintenance District No. 1 (LLMD No.1). A third amendment to the Contract Services Agreement is being proposed to provide a three-year contract extension with no increase in contractual costs for the entire term.

Recommendation: Authorize the City Manager to amend the Contract Services Agreement for landscape maintenance services for LLMD No. 1, in a form approved by the City Attorney, for a three-year term, with a contract amount of \$29,180 annually.

- c. Extension of Contract Services Agreement with Valleycrest Landscape, Inc. for Landscape Maintenance Services of Hilltop Park and Sunset View Park

Summary: The City hired ValleyCrest Landscape, Inc. to provide landscape maintenance services at Hilltop Park and Sunset View Park in 2008. A second amendment to the original Contract Services Agreement is being proposed to provide a two-year contract extension under the current terms of the contract, with no increase in costs over the two-year term.

Recommendation: Authorize the City Manager to execute an amendment to the Contract Services Agreement with ValleyCrest Landscape, Inc. for landscape maintenance services at Hilltop Park and Sunset View Park. The amendment will provide a two-year extension of the existing contract under the contract's current terms including no increase to the annual cost.

- d. League of California Cities – Amendments to League Bylaws

Summary: At its February meeting, the League's Board of Directors approved submitting two amendments to the League's Bylaws to the membership. The proposed amendments would amend the Bylaws to provide that: 1. Resolutions submitted to the League for presentation to the General Assembly must be concurred in by at least five or more cities or by city officials from at least five or more cities. 2. The League Board may take a position on a statewide ballot measure by a 2/3<sup>rd</sup> vote of those Directors present. Currently, the Board may take positions with a simple majority vote.

Recommendation: Approve the amendments to the League bylaws and authorize the Mayor to mark and sign the ballot.

e. Claim for Damages

Summary: The City has received a claim for financial reimbursement from Stephanie Kutil for property damages.

Recommendation: Deny the claim of Stephanie Kutil.

f. Claim for Damages

Summary: The City has received a claim for financial reimbursement from Duke Alloh for property damages.

Summary: The City has received a claim for financial reimbursement from Sharon Valdez for bodily injury.
