City Attorney requested the addition of the following items to the agendas:

1. Assignment of Agency Funds to City and Authorization of City Manager to Sign Contracts with Approval from the City Council

Summary: The Signal Hill Redevelopment Agency was established in 1974 pursuant to provisions of the California Health and Safety Code. The primary purpose of the Agency is to eliminate blighted areas by encouraging development of residential, commercial, industrial, recreational and public facilities. The City has approved and adopted a redevelopment plan for the Signal Hill Redevelopment Project No. 1 and has established a low and moderate income housing fund to be used for the purposes of increasing, improving and preserving the City's supply of affordable housing. Over the years, the Agency has acquired, remediated, and developed many properties throughout the City of Signal Hill, thereby eliminating blight, providing viable businesses, affordable housing and generating jobs and sales taxes for the community.

The Governor's proposal to eliminate redevelopment would stop all redevelopment efforts in process by the Agency. The Signal Hill Redevelopment Agency has pending projects that it has planned to start within 90 days. The following action would transfer funds from the Agency to the City's general fund so that the planned projects can be implemented. In addition, this action allows the City Manager to sign contracts pertaining to this work.

Recommendation: Waive further reading and adopt the resolution approving the transfer of Signal Hill Redevelopment Agency funds to the City of Signal Hill for the purposes outlined in the resolution and authorizing the City Manager to sign contracts for projects related to the purposes outlined hereto.

2. Assignment of Agency Leases to City of Signal Hill and Appointment of City to Administer Leases

Summary: The Signal Hill Redevelopment Agency was established in 1974 pursuant to provisions of the California Health and Safety Code. The primary purpose of the Agency is to eliminate blighted areas by encouraging development of residential, commercial, industrial, recreational and public facilities. The City has approved and adopted a redevelopment plan for the Signal Hill Redevelopment Project No. 1 and has established a low and moderate income housing fund to be used for the purposes of increasing, improving and preserving the City's supply of affordable housing. Over the years, the Agency has acquired, remediated, and developed many properties throughout the City of Signal Hill, thereby eliminating blight, providing viable businesses, affordable housing and generating jobs and sales taxes for the community.

The Agency has played a critical role in the establishment of the Signal Hill Auto Center as well as its growth. The Agency is requesting that the current leases for Auto Center properties be transferred to the City at this time.

Recommendations: 1. Transfer funds from the Agency to the City for the Master Lease Agreement. 2. Authorize the Executive Director of the Signal Hill Redevelopment Agency to transfer the Master Ground Lease-Alda C. Jones Trust to the City of Signal Hill via an "Assignment and Assumption of Master Lease Agreement." 3. Authorize the Executive Director of the Signal Hill Redevelopment Agency to transfer the Sublease Agreement-Davis/Glenn E. Thomas Dodge to the City of Signal Hill via an "Assignment and Assumption of Sublease Agreement." 4. Authorize the Executive Director of the Signal Hill Redevelopment Agency to transfer the Sublease Agreement-Autrey/BMW to the City of Signal Hill via an "Assignment and Assumption of Sublease Agreement." 5. Authorize the Executive Director of the Signal Hill Redevelopment Agency to transfer the Sublease Agreement-Mercedes Benz to the City of Signal Hill via an "Assignment and Sublease Agreement".

Summary: This resolution declares the City's intent to vacate a portion of the cul-de-sac adjoining Orizaba Avenue north of Pacific Coast Highway. The Planning Commission has found the vacation of this right-of-way to be consistent with the General Plan. The resolution also sets a public hearing to receive public comment on this matter.

b. Resolution Declaring Final Acceptance of the Reservoir Park Improvements Project, No. 725

Summary: Mega Way Enterprises has completed the Reservoir Park Improvements Project, No. 725, to the satisfaction of the Public Works Department. Staff is recommending final acceptance of the work performed by Mega Way Enterprises.
