

MINUTES OF A REGULAR MEETING SIGNAL HILL CITY COUNCIL

August 16, 2011 7:00 p.m.

A Regular Meeting of the Signal Hill City Council was held in the Council Chamber of City Hall on August 16, 2011.

Assistant City Attorney reported on closed session items. Status reports were given and directions from Council. No reportable action was taken.

a. Interim Urgency Ordinance Adopting Interim Regulations for the Development of Properties with Abandoned Oil Wells Pending Completion of Special Studies Necessitated by Recent Policy Changes of the State Division of Oil, Gas and Geothermal Resources Concerning Developing Projects Adjacent to or on Top of Abandoned and Re-Abandoned Oil Wells

City Manager and Community Development Director presented the staff report.

Council Member Wilson asked questions regarding development projects and Community Development Director addressed questions.

It was moved by COUNCIL MEMBER WARD and seconded by VICE MAYOR HANSEN to waive further reading and introduce Ordinance No. 2011-08-1430 adopting interim regulations for the development of properties with abandoned wells pending the completion of studies on how the Signal Hill Oil Code shall address the health and safety issues of oil wells caused by the policy changes of the State Division of Oil, Gas and Geothermal Resources concerning abandoned oil wells.

City Attorney read the title of Ordinance No 2011-08-1430:

AN INTERIM URGENCY ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, ADOPTING INTERIM REGULATIONS FOR THE DEVELOPMENT OF PROPERTIES WITH ABANDONED OIL WELLS PENDING THE COMPLETION OF STUDIES ON HOW THE SIGNAL HILL OIL CODE SHALL ADDRESS THE HEALTH AND SAFETY ISSUES OF OIL WELLS CAUSED BY THE POLICY CHANGES OF THE STATE DIVISION OF OIL, GAS AND GEOTHERMAL RESOURCES CONCERNING ABANDONED OIL WELLS

c. Property Acquisition – 1917 E. 21st Street

City Manager introduced the Economic Development Manager who presented the staff report.

Maria Harris, Signal Hill resident addressed Council and asked a question regarding eminent domain. City Manager confirmed the property is not being acquired under eminent domain.

It was moved by COUNCIL MEMBER WARD and seconded by COUNCIL MEMBER WILSON to authorize the City Manager to execute an Agreement for Purchase and Sale of Real Property between Elre Holdings, LLC and the City of Signal Hill for property located at 1917 E. 21st Street and approve the budget adjustment appropriating \$195,000 from the Park Development Fund (Fund 50) to Account No. 050.640.545.788.

b. Award of Contract for the Cerritos Avenue Improvements Project, No. 804

<u>Summary:</u> On August 2, 2011, the City received bids for the Cerritos Avenue Improvements Project, No. 804. Staff is recommending an award of contract to Palp, Inc. dba Excel Paving.

<u>Recommendation:</u> Authorize the City Manager to award a contract for the Cerritos Avenue Improvements Project, No. 804, in a form approved by the City Attorney to Palp, Inc. dba Excel Paving in the amount of \$183,142.90.
