Dear Ms. Mancini,

Many positive changes have occurred at Long Beach Animal Care Services over the past years to improve response times to calls for service, enhance animal care, and expedite law enforcement activities. Some of the recent innovations and improvements include:

- In 2019, Long Beach Animal Care Services (LBACS) entered into an Agreement with the Helen Sanders Cat Protection and Welfare Society (CatPAWS) and The Little Lions Foundation (LLF), to operate a kitten nursery in a commercial location located in Long Beach to nurse LBACS-provided kittens through to adoptable health and age. The kitten nursery under the title of the Long Beach Little Paws Project (LBLPP) saved 434 kittens by the end of 2019.
- In 2020, Animal Care Services achieved an overall live release rate of over 90%.

Additionally, it gives our staff great pleasure to have provided animal care and control services to the City of Signal Hill. The **contracted compensation for the period of October 1, 2020 – December 31, 2020** is **\$26,567.25**, which is 25% of the FY21 service contract amount of \$106,269.00. During the period of October 1, 2020 – December 31, 2020, the Animal Care Services Bureau collected **\$2,954.00** in pet license revenue on behalf of your residents as evidenced in the attached invoice. Field officers also completed **84** calls for service.

Consequently, we are submitting a request for the sum of **\$23,613.25**, which is the difference between the contracted amount and the dog license revenue collected. A more detailed monthly breakdown of dog license revenue for the 2nd quarter of FY20/FY21 is enclosed.

Please contact me if you have any questions. Our team looks forward to another great year of serving the City of Signal Hill.
