 3. A permit fee of \$20.00 must be submitted with the application. Handicapped permits will be free of charge. (With City Manager Approval). Section 10.030.080 Section C. Application must be processed at Signal Hill City Hall.
 4. Permit stickers must be affixed to the inside of the driver's window.
